Why is addressing health inequalities important for you?

- AACE National Consensus Statement commitment to strengthening role of ambulance sector in reducing health inequalities
- National guidance and legal requirements for Trusts to consider and try to reduce health inequalities (i.e. NHSE, Health & Care Act 2022 etc)
- Changing population needs need to support preventative care to ensure ambulance service has resources available to provide their core model of immediate reactive care
- Role of ambulance sector as an anchor institution vital role in communities & unique access to data that should help inform planning across the system
- Need to link and integrate with wider system partners to tackle population needs – cannot be done in isolation





Current Portfolio / Case Study

We have experience working with one large ambulance trust to date, where our population health management offer has consisted of:

- Health Needs Assessment
- Linkage of data sets ambulance, primary care and secondary care data to fully understand needs of the population (split for 111 and 999 cohorts)
- Creation of dashboards to demonstrate this data in a meaningful way
- Deep dives into data in specific areas to support clinical strategy development and targeting of interventions
- Development and implementation of Trust Health Inequalities Plan
- Programme management support
- Board training development sessions with a focus on health inequalities
- Establishing links with external stakeholders, ICB and place-based leads to promote work undertaken by the Trust and ensure they are included in present and future planning discussions
- Research into how we deliver services in other areas to look for areas of best practice and share learning
- Linking with peer trust groups and AACE colleagues
